My first 6 weeks on the job have been filled with meetings, tenant visits, reading volumes of project files and talking with both Liz and Dennis about the operation of the airports.

Although I don't feel I am anywhere near "up to speed", I do feel I am in a position where I can effectively begin to address many of the airport issues. The following are some of the things that I have accomplished so far.

- Walked around Columbia Airport and met all the current commercial tenants
- Set up an office paper recycling program
- Obtained 2 Resolutions authorizing me to apply for CalTrans matching grants
- Obtained contract with Cingular Wireless for the installation of a cell transmitter on the Mt. Brow beacon
- Attended the Assoc. of Calif. Airports conference
- Formed a user's group at PML to address pedestrian access issues

- Reconditioned both windsocks at PML with the help of local pilots
- Monitored the final stages of construction of the Columbia airport ramp renovation and grass runway construction
- Spoke at the November TCAA meeting
- Set up regular office hours at PML
- Prepared a list of future projects at for both Columbia and PML for FAA grant application
- Modified the Columbia AWOS so that a continuous message is broadcast regarding the closure of the grass runway

I hope you can see that I am taking the Airports Director's job seriously and will work hard to improve our airports.

Rich McGlashan & Ken Helling Helped Recondition Both PML Windsocks

Thanks to the help of a few residents at Pine Mountain Lake, both windsocks were completely reconditioned. Several pilots had complained that the west windsock was nearly invisible due to sun fading of the windsock fabric. Also, it squeaked when it rotated in the wind indicating the bearings needed servicing. The lighted windsock located adjacent to the wind tee often times contradicted the wind tee. It was noted that the windsock mount was slightly bent and that the light support was broken.
