If you're drinking alcoholic beverages please be careful of DWI check points . There might be one on the corner of your kitchen and living room 🖭




PML Airport Celebrates 50-Years ... with a Back Taxiway - by Janet Gregory

Pine Mountain Lake is enjoyed for its many amenities: the golf course, restaurant & lounge, stables, airport, and more. Bert Pike and Terry Bruce expanded the vision for PML's airport by creating a fly-in community with lots flanking the runway and extending into the community with a back taxiway.

Residential airparks were not a novel concept in 1970 when PML Airport was certified. Sierra Sky Park in Fresno was the first fly-in community, established in 1946. Today there are approximately 425 residential airparks in the US, 28 in California. Only Florida and Washington have more, with 50+ in each state.

Originally 99 lots at the airport were designed with taxiway access: 73 on the north side of the runway and 26 on the south side. North side taxiways are privately maintained by property owners. Forty two properties line the back taxiway. Sources vary slightly on these figures.



One creative homeowner on Woodside Road had no taxiway access but built a hangar anyway. Initially he tried to access the taxiway via Woodside Road, but that resulted in complaints and a post placed in the center of the road at the taxiway intersections. Next, he purchased one of the paved lots and used it to taxi through to his hangar. That worked for a while, but again, more complaints. Several people ran into those posts so they didn't last long.

The back taxiway was paved at the same time the roads in Units 11 and 12 were paved. The back taxiway is owned by property owners on either side. Property pins are situated down the center of the taxiway. Walking the taxiway, you can see many marked with paint; unmarked pins are easy to find with a metal detector or magnetometer.

Shared-ownership of the back taxiways should have been addressed by Boise Cascade before any properties were sold but unfortunately it wasn't. As a result, resurfacing tends to be a fractious and unpopular issue. If PML were constructed today, California Civil Code would require a maintenance agreement that accounted for property owner "benefit" by distance from entrance/exit and span of right-of-way.

The back-taxiway was designed as a one-way loop. Aircraft would enter at the west end (9er approach) near Woodside Road, and exit at the east end (at the mid-field crossover) near Jimmersall Lane. Few airplane traffic problems, the use of radio calls, and today it is a two-way taxiway for efficiency allowing pilots to taxi the shortest distance.

Aircraft parking was originally located on the back taxiway. PML owned two lots, paved them, and provided tie-down spots for residents and visitors. Walking the taxiway, one of the two lots is still visible, the other has a hangar-home on it. PML eventually sold these properties and did not want to provide aircraft parking due to security and liability concerns.

Amenities are important to the design of Pine Mountain Lake. The lake and marinas, golf course, equestrian center, walking paths, shooting range, tennis, and the airport bring people to the area. Amenities add activities, enjoyment, and resilient property values to owners. The back taxiway expanded airport accessible lots by more than 40%.

May Day has come and gone. Only one person at a time could dance around the May Pole. Shelter-in-place (SIP) is still the "Order of the Day." Thankfully things are slowly starting to reopen.



Many aviation events have cancelled, including the EAA's Air Venture at Oshkosh and the EAA Ford TriMotor Flights on tour. Father's Day Fly-In at Columbia Airport (O22) has been cancelled for the first time in 54 years, as has the 40th Salinas Air Show. The Reno Air Races moved Pylon Racing School out to September, just before the National Championship Air Race Event. Some events as far out as October have cancelled, like the Livermore Air Show, but others have not, like the PML Community Airport Day and Sacramento's Capital City Air Show. Stay tuned. We do have to follow State and Federal Covid-19 guidelines but, like Oshkosh organizers, there is the fear that no one will come.

So, what is our local EAA chapter 1337 up to? Thanks to Wayne Handley, Allen Craig, and some others that procured and installed a new BIG Wind Sock at the Wind-T. We have not been able to work on the KOLB Ultralight build project under SIP but Jeremy Zawodny has some new information to share and we will schedule a covering demo by Ken Orloff as soon as possible.

Rob Compton has ordered the Runway Reflectors, working closely with PMLAA. He will coordinate a work party schedule when feasible. Thanks, once again to Bob Mackey for procuring, cutting and delivering the steel tubes required for Reflector installation.

If you are desperate for an aviation or EAA fix, they have Monthly Seminars on line and an extensive library to watch. You can pick up some pointers or even a new skill.

For now, our local EAA chapter 1337 continues to plan for the Young Eagles Rally at PML Airport (E45) on Saturday, October 10th to help inspire our next generation of aviators. If you have any questions contact me at 962-5061.

E45 Oil dump has been cleaned out.

- 1. Thank you, Mike Gustafson, President of Oil Dump Operations!
- 2. In April about 800 gallons of oil were removed from oil dump storage for reclamation. This clean out should be good for about 3 more years.
- 3. Please <u>do not leave oil bottles or boxes</u>. Plastic oil bottles and cardboard boxes can be recycled at Moore Brothers in Big Oak Flat at no charge.
- 4. Please <u>do not leave oil filters</u>. Oil filters can be recycled at AutoZone or O'Reilly Auto Parts in Sonora or when Moore Bros does hazardous waste recycling. Unfortunately, NAPA Auto Parts in Big Oak Flat does not accept them.

• Interesting (and even useful) Aviation Windsock Facts

- According to FAA specifications (Circular 150/5345-27E), windsocks may be orange, yellow, or white, either solid, striped, or alternating colors. Other FAA specs include information on framework, fabric, and lighting.
- At E45, we have a solid orange windsock at the Wind-T and alternating orange and white at the approach end of 9er.
- How to read a wind sock
 - o Windsocks are made to orient themselves against the wind when wind speed reaches 3-knots (3.5 mph), at that speed the first segment of the sock extends.
 - The second segment of the sock extends when the win reaches 6-knots, the third segment at 9-knots, and the fourth at 12-knots.
 - At a wind speed of 15-knots (17 mph) or more the windsock will be fully extended.
- History: Around 150 CE, Romans used colorful windsock-like banners to identify
 different divisions of the military. In the 19th century, sailing ships used wind-sails
 shaped like tubes or funnels to transport oxygen to lower levels of the ship. These windsails are believed to be the inspiration for the modern windsock.
- *Technology:* Truth is that today pilots have much more accurate ways to find out wind speed and direction but when technology fails the noble windsock is invaluable.
- Hummingbird short stories ... heard in the wind
 - We are tired of SIP (shelter-in-place), and want to GULP (gain-unrestrained-life-passage)
